ORDINANCE No. 2011-ROAD

An ordinance levying taxes for all road purposes for Grant Township Road District, Lake County, Illinois for the tax year 2010, collectable in 2011.

BE IT ORDAINED by the Board of Trustees of Grant Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Grant Township Road District on December 7th, 2010 does hereby determine and declare that the sum of Eight hundred Ninety-three Thousand (\$893,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all of the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ROAD & BRIDGE, SOCIAL SECURITY FUND,

EQUIPMENT & BUILDING, INSURANCE,

ILLINOIS MUNICIPAL RETIREMENT FUND,

For the year 2010.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
