Lake County Northwest Demonstration Project*

Weekday Curb-to-Curb Dial-A-Ride Service in the four Northwest Townships of Lake County, IL.

The NW Demonstration Project is a Dial-a-Ride service that operates Monday through Friday within the four Northwest Townships in Lake County. **On October 11, 2010, the service area expanded to take residents of the four Northwest Townships to commercial/retail locations in the Gurnee Mills Area in an effort to connect people with jobs. Please refer to the attached revised service map and contact the Call Center for specific eligible destinations in the Gurnee Mills Area.**

Eligibility:

- Riders must be a resident of Antioch Township, Avon Township, Grant Township, or Lake Villa Township and must register for the service
- Trips must originate and terminate within Antioch Township, Avon Township, Grant Township, Lake Villa Township or the expanded Gurnee Mills Service Area. This service gives priority to people with disabilities, but is open to the general public.

Service Hours:

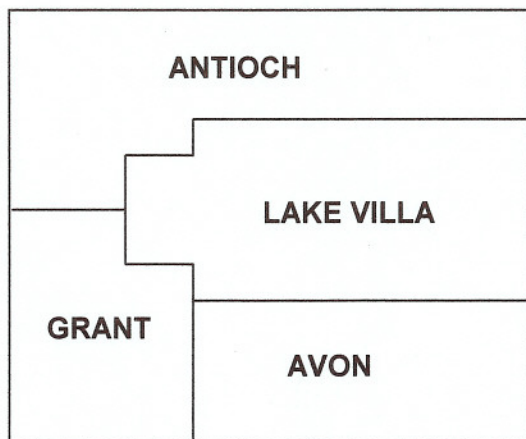
- The first scheduled pick-up time for the NW Demonstration Dial-A-Ride is at 5:30 A.M. and the last scheduled pick-up time is at 6:45 P.M. for travel anywhere within the 4 northwest townships of Lake County, IL.

Fares:

- **One-way cash fare is \$2.00 for people with disabilities and seniors; \$4.00 all others.**
- Exact change required on the bus. Ride coupons are available through the participating townships.

Reservations:

- Ride requests need to be scheduled one day in advance. Rides are set up on a first-come first-served basis & are subject to bus capacity.
- **Seniors and people with disabilities may make 7-day advance registration for work and medical appointments beginning Oct. 11, 2010.**
- Reservation hours for trip requests are Monday through Friday from 6:00 am to 7:00 pm. People with disabilities will be given priority service from 6:00 am to 12:00 pm. General public riders may call from 12:00 pm to until 7:00 pm for reservations.
